Thai Enquirer News Summary

Political News

- The Constitutional Court announced that the next hearing for the case against Prime Minister Srettha Thavisin will be held on July 24, adding that it was waiting for more information.
 - ❖ The charter court's panel of 9 judges deliberated on the case file against Srettha by a group of 40 senators. He was accused of breaching ethical standards and the Constitution by appointing Pichit Chuenban as a PM's Office minister despite his questionable background.
 - ❖ After the meeting, the Constitutional Court announced that the judges wanted more information on the case and were waiting for certain individuals and agencies to

respond to inquiries. The announcement did not elaborate on what kind of additional information the court is seeking.

- ❖ This move puts more pressure on the Prime Minister as the case has been in the Constitutional Court since May 17, 2024
 - The Constitutional Court has so far taken 49 days since the date it accepted the petition, and it could take up to 80+ days to give its verdict (if the verdict is given on August 9, 2024)
 - 2014 coup leader Prayut Chan-o-Cha's case in the same court was decided within 38-days.

- After nearly 2-weeks the Election Commission certified the 200 ‘selected/elected’ Senators certified the botched-up process.
 - ❖ Yesterday, the Royal Gazette website published an official announcement from the Election Commission regarding the election results for members of the Senate.
 - ❖ As a result, the 250 outgoing senators were immediately removed from their positions under Article 109 of the Constitution.
 - ❖ The Secretary-General's Office of the Senate will open for newly elected senators to report to the Parliament building between July 11-12 and on July 15.

- The Election Commission (EC) finally certified the list of 200 new senators and 100 reservists yesterday, following the last round of voting on June 26. The senators-elect are required to receive their certificates from the EC on July 11 and 12, so that they can report to the Secretariat of the Senate.

ทั้งนี้ ภายหลังจากประกาศผลการเลือกตั้งแล้ว ยังมีหลักฐานอันควรเชื่อได้ว่าผู้สมัครหรือผู้ใดกระทำการทุจริตในการเลือกตั้งหรือขึ้นกับการกระทำของบุคคลอื่น ที่ทำให้การเลือกตั้งไม่เป็นไปโดยสุจริตหรือเที่ยงธรรม คณะกรรมการการเลือกตั้งสามารถยื่นคำร้องต่อศาลฎีกาเพื่อสั่งให้เพิกถอนสิทธิสมัครรับเลือกตั้ง หรือเพิกถอนสิทธิเลือกตั้งของผู้ใด



- ❖ The EC disqualified Kordiyoh Songngam, a female former village chief, in the media background group, who won in Ang Thong province because she was found to be working as an advisor to the president of the Ang Thong Provincial Administrative Organisation. A reservist in the same background group, Korapot Runghiranwat, was moved up to replace her.
- ❖ EC Secretary General Sawaeng Boonmee told reporters that the announcement was made after they had determined that the election process was implemented legitimately, according to the law and with fairness.
- ❖ There are about 800 complaints filed with the EC, Sawaeng said, adding that investigations into those complaints will continue and, in some cases, they will ask for assistance from the police.



- It was reported that 2 out of 7 members of the EC voted to postpone the certification including Lertvirot Kowattana and Thitichat Nuchanart.



- Kordiyoh Songngam stated that she will pursue legal action against the EC's decision because she did not hold the position on the election registration date. She also claimed she was informed by the EC officials that she could run for the Senate seat during the registration.



- Parliament unanimously voted to lift the previous junta's Order 14/2016, which restricted public participation in managing the conflict in the southern border provinces and allowed excessive military influence in the administration of the three southernmost provinces.
 - ❖ This decision will dissolve the advisory committee established by the now-defunct National Council for Peace and Order (NCPO) to oversee the Southern Border Administration and Development, which included members representing residents of the southern region.

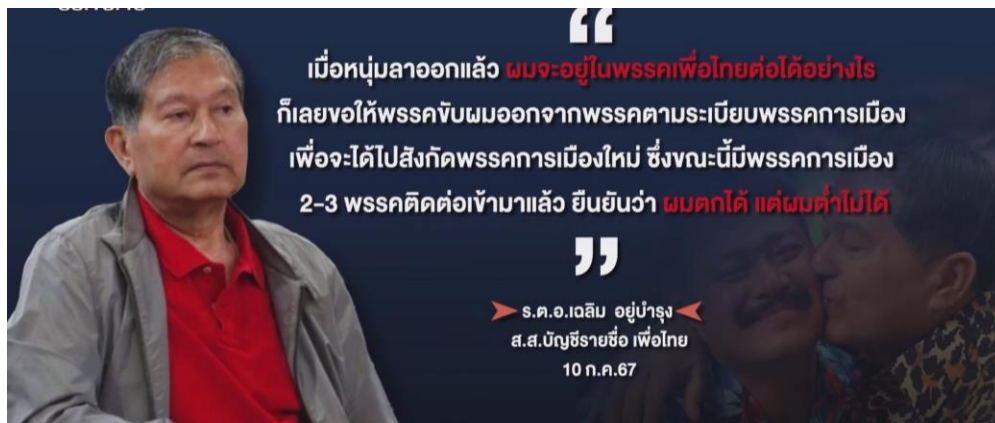


- On July 14, former Prime Minister Thaksin Shinawatra will attend a ceremony at Wat Suwannawichit in Surin province. The event is set to be attended by Surin MPs from the Phue Thai Party and many Red Shirt supporters in the area, as it marks Thaksin's 1st visit to the northeastern Isaan region since returning to Thailand.
 - ❖ Meanwhile, Prime Minister Srettha Thavisin has scheduled visits to Chiang Rai and Sa Kaeo provinces from July 12 to 14 to monitor water management efforts aimed at preventing flooding and drought issues in the area.
- Wan Yubamrung, Vice Minister to Public Health Minister Somsak Thepsuthin, resigned from his position after Pheu Thai Party leader Paetongtarn Shinawatra was upset that he appeared at the house of Pol Lt Gen Kamronwit Toopkrajang on the day of the election for the president of the Pathum Thani Provincial Administrative Organisation.

- ❖ Chalerm, a senior Pheu Thai figure and Wan's father, told the party to expel him after his son resigned as Vice Minister to the health minister. He stated that his son was asked to stop his duties, which led to his decision to resign.



- Chalerm also mentioned that a couple of parties have already invited his son to join them.



- The disagreement over reclassifying marijuana flowers as narcotics will not affect the unity between the ruling coalition partners, said the Bhumjai Thai Party. However, the party urged the coalition partners to consider the party's marijuana control bill, which they are reintroducing to Parliament, as another option besides the reclassification.
 - ❖ They stated that many people have already invested in marijuana-related businesses since it was decriminalized two years ago, and a policy U-turn would significantly impact them. They noted that the current problem is the lack of regulation to control the sale and use of marijuana and that the bill, which they repropose last September, would address this issue.
- The Thailand Cannabis Future Network said in a Facebook post on Wednesday that members of the group who are part of the stakeout outside Government House will go on a hunger strike if marijuana is added to the list of Category 5 Narcotics without a comprehensive study on the plant's use.



- ❖ The group began campaigning outside Government House on Monday when the Public Health Ministry’s panel on narcotics control voted last week to return marijuana and hemp to the list of Category 5 drugs.
- ❖ The cannabis advocates said in a statement that reclassifying marijuana as a drug would be like jailing a suspect without trial. “We will stage a hunger strike unless the government agrees to conduct a trial before coming up with a verdict against cannabis,” the statement said.

Economic News

- Deputy Finance Minister Julapun Amornvivat revealed after the subcommittee meeting on the implementation of the 10,000 Baht digital wallet project that the Budget Bureau and the Ministry of Finance suggested the project’s funding source might not need to come from the Bank for Agriculture and Agricultural Cooperatives (BAAC).



- ❖ According to the Fiscal Policy Office, past government projects, such as the co-payment scheme, had a participation rate of only 90%. Therefore, while the current

government aims to cover 50 million people with the digital wallet project, the budget preparation will likely be capped at 90% or 450 billion Baht.

- Julapun said this can be managed through the 2024 budget, which will allocate around 160 billion Baht, including an additional budget of 122 billion Baht and 43 billion Baht from other sources.
- ❖ For the 2025 fiscal year, a budget of 280 billion Baht will be set, comprising 152 billion Baht from the budget allocation and 132 billion Baht from other sources.
- ❖ Meanwhile people who receive the government's 10,000-Baht handout will not be able to use the digital cash to buy mobile phones, electrical appliances or electronic devices. The products were put on a so-called negative list by a government sub-committee working on the details of the programme.
- ❖ The digital money being given to as many as 50 million eligible people cannot be spent on these products because the government wants to ensure it will be spent at small shops, not big department stores.

- Prime Minister Srettha Thavisin will not attend today’s parliamentary meeting to directly respond to economic questions from Sirikanya Tansakun, MP from the Move Forward Party, said Phakamon Noonanan, MP and Deputy Spokesperson for the Move Forward Party.
- ❖ Phakamon said that this is the 2nd time the Prime Minister is unavailable to address live questions, despite it being his duty to do so. Nevertheless, if the Prime Minister does not attend, the Move Forward Party will not ask these live questions but will use the allocated time to inquire about other issues instead.

- ❖ As for the economic issues, the party will wait until the Prime Minister is available, Phakamon said.

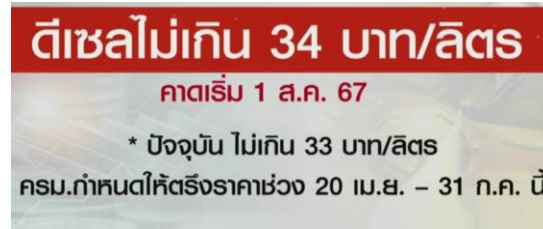


- Deputy Prime Minister and Minister of Finance Pichai Chunhavajira will discuss with Sethaput Suthiwartnarueput, the Governor of the Bank of Thailand (BoT), about revising the criteria for housing loan regulations (Loan to Value: LTV).
 - ❖ Pichai said the LTV limits were established when non-performing loans (NPLs) were not as severe as they are today. Currently, many issues have intensified, and the real estate sector continues to face problems, especially with slowing purchasing power.
 - Buyers are struggling to repay debts, and NPLs are expected to rise above 3.5%. Including nearly 5% of debts classified as Special Mentions (SM), the bad debt could increase to nearly 8%.
 - ❖ He said Thai economy has been facing a structural problem for a long time, and with high household debt, GDP growth is expected to expand by 2.5% this year compared to nearly 6% in the past. The government is working to boost growth to 3% in 2024, compared to the average growth of around 1.7% over the past decade.



- The Ministry of Energy is set to increase diesel prices gradually from August 1, 2024, with a cap of 34 Baht per liter to maintain the liquidity of the Oil Fuel Fund, according to

sources. This decision follows the incoming expiration of the Cabinet's decision to maintain the diesel prices at no more than 33 Baht per liter from April 20 to July 31, 2024.



- ❖ As of July 7, 2024, the Oil Fuel Fund is in deficit by 111.595 billion Baht, and global diesel prices are rising again, necessitating over 2 Baht per liter in subsidies. Without a price adjustment, the financial situation of the Oil Fuel Fund will worsen, sources reported.

- ❖ Apichart Prairungruang, President of the Federation of Land Transport of Thailand, warned that if diesel prices rise, the federation will immediately increase transportation fees and mobilize truck protests. The federation has submitted letters to government agencies four times regarding this issue and will not submit any more, Apichart said.
- According to Poonpat Leesombatpiboon, Secretary-General of the Energy Regulatory Commission (ERC), the ERC will announce details and options for the new formula for calculating the fuel tariff rate (FT) on Friday, July 12, 2024. The current rate is 4.18 Baht per unit.
 - ❖ Bualuang Securities stated that stocks expected to benefit the most from this FT rate increase are BGRIM and GPSC. They estimate that every 10 satang per unit increase in the FT rate will boost BGRIM's profits by 3% and GPSC's profits by 4%.
- SET-listed Syn Mun Kong Insurance (SMK)'s license has been revoked. This came after the Office of Insurance Commission (OIC) instructed SMK in December 2023 not to accept

new applicants following the Central Bankruptcy Court's revocation of its rehabilitation petition.

- ❖ The insurance company had filed the rehabilitation plan in April 2022 after facing significant losses due to its Covid-19 payment policy. Additionally, the Office of Insurance Commission issued an order to appoint the General Insurance Fund as the liquidator for Syn Mun Kong Insurance.



General News

- A special House panel will summon representatives of Charoen Pokphand Foods to testify over the uncontrolled infestation of an alien species fish in 13 provinces.
 - ❖ Move Forward Party MP Natcha Boonchai-insawat, who chairs the subcommittee in charge of investigating the source of the blackchin tilapia infestation, said CPF executives would be invited to testify today.
 - ❖ Earlier, the Department of Fisheries announced that it had detected blackchin tilapia, which originates from Africa, in the water resources of 13 provinces. The department has launched campaigns urging local people to catch and annihilate the alien fish for fear that it would annihilate local species.
 - ❖ Natcha said his panel, which is a subcommittee of the House committee on higher education, science and innovations, had learned that CPF had got approval from the

fisheries department in 2006 to import some blackchin tilapia on the strict condition that it must not let the alien fish slip out into the natural water resources.

- ❖ CPF said it wanted to experiment mixed-breeding the blackchin tilapia with Nile tilapia to improve the quality of Nile tilapia.
