Thai Enquirer News Summary

Political News

- Media is buzzing with reports that focuses on the plans by Phue Thai party to dump Bhumjai Thai party (BJT) from the coalition.
 - ❖ BJT, which has 68 MPs, has been a hurdle in the process of putting forward the various policies of Pheu Thai.
 - If 68 MPs are dumped the coalition will be left with 251 MPs. There are 493 MPs in the current parliament as some have been banned and can't be replaced, the actual strength of the parliament normally is 500.
 - The key is that as many as 25 MPs of People's Party are being investigated for signing the documents to amend Article 112 and could be banned from

politics, thus leaving the need to have just 234 MPs in the parliament to have a majority.



- ❖ The break in the 2 coalition partners comes amid ongoing moves by BJT to keep blocking moves by Pheu Thai party.
- ❖ To make matters worse, the 2nd deputy speaker of the parliament Paradorn Prissanananthakul, made a statement on the last day of the parliamentary session on April 11, 2025, when Paradorn said in the closing remarks that he does not know if the MPs seated here will have the opportunity to meet the next time or whether there will be a snap election.
- ❖ To add further salt to the wound was the son of the de-facto leader of BJT
 - "I, Chaichanok Chidchob, the eldest son of Newin and Karuna Chidchob and secretary-general of the Bhumjai Thai, will ultimately never agree (to legislation) to open casinos or any similar legislations including those which may be filed by the Bhumjai Thai."
- Today, Prime Minister Paetongtarn Shinawatra will welcome Anwar Ibrahim, the Prime Minister of Malaysia, on his official visit to Thailand for a working visit.
 - ❖ The visit aims to follow up on progress from previous meetings between the 2 countries and further promote bilateral cooperation between Thailand and Malaysia.



- Anwar Ibrahim is set to hold many discussions and will also meet former Prime Minister Thaksin Shinawatra and Myanmar junta leader Min Aung Hlaing that is slated to be a meeting that is to find a solution to the problems in Myanmar, a key member of the 10-member Asean grouping.
- Kannavee Suebsang, a list-MP from the Fair Party from the opposition bench has called for transparency ahead of a planned meeting in Bangkok involving former prime minister Thaksin Shinawatra, Malaysian Prime Minister Anwar Ibrahim, and Myanmar junta leader Min Aung Hlaing.
 - ❖ Anwar previously said he would meet both Thaksin and Min Aung Hlaing in Bangkok to support efforts to extend a ceasefire between the Myanmar military and ethnic armed groups, aimed at facilitating earthquake relief. The ceasefire, which began just before Min Aung Hlaing attended the BIMSTEC Summit in Bangkok, is set to run until April 22, although independent monitors report continued clashes.
 - ❖ He said that if the meeting was initiated by Thaksin, who is also the father of the current prime minister, the government should disclose the meeting's location, agenda, and outcomes. The decision to host the talks in Thailand, questioning why Malaysia did not use its own diplomatic channels or why the meeting was not held in Myanmar.




- Wiroj Lakkhanaadisorn, Deputy Leader of the People's Party, announced that on April 21, a press conference will be held to address three issues that the opposition may forward to the National Anti-Corruption Commission (NACC) for further action following the noconfidence debate.
 - ❖ These three issues include whether the Prime Minister engaged in a disguised legal transaction by using PN tickets to evade taxes, questions surrounding the land title deed of the Thames Valley Khao Yai Hotel, and Thaksin's prolonged stay at the Police Hospital.
 - Meanwhile, Ruangkrai Leekitwattana revealed that he has sent an EMS letter to the Prime Minister requesting a review of the 2024 personal income tax payment of

Paetongtarn to verify whether she has fully complied with Sections 40 (1) and (5) of the Revenue Code.



- The Appeals Court has upheld the shutdown of a website that promoted the repeal of the lèse-majesté law, according to Internet Law Reform Dialogue (iLaw).
 - ❖ The case began in October 2021 when the Khana Ratsadon to Abolish 112 group launched a petition to repeal Section 112 of the Criminal Code (the lèse-majesté law). The petition, available both online at http://no112.org and in paper form, gathered over 100,000 signatures within 24 hours.
 - ❖ However, the website became inaccessible in February 2022, displaying a notice from the Ministry of Digital Economy and Society stating it had been blocked due to alleged violations of the Computer Crimes Act. It was later revealed that the Criminal Court initiated an inquiry on February 1, 2022, following a request under the Computer Crimes Act. The court ordered the shutdown of the website on February 12, 2022.
 - ❖ Arnon Nampa, the human rights lawyer and detained prominent pro-democracy activist who had proposed the bill to repeal the law, filed an objection to the shutdown. The complainant, Pol. Lt. Col. Phanlarn Pathompornwiwat, requested the court to block or remove 52 URLs, including http://no112.org, claiming they violated public order or morality. These sites spread content harmful to public order and needed to be blocked to prevent further dissemination.

Economic News

- Yesterday Pichai Chunhavajira and the Governor of the Bank of Thailand (BOT), Sethaput Suthiwartnarueput, have held in-depth discussions to formulate strategies to address the potential impact of US President Donald Trump's trade policies. The two have committed to closer collaboration to ensure Thailand is well-prepared for any economic fallout.
 - ❖ Pichai revealed that the potential effects of the US tariffs, which are expected to impact multiple nations, were the primary focus. They discussed various scenarios, considering not only direct exports to the US but also the potential knock-on effects on exports to other trading partners, which could have significant economic repercussions.
 - ❖ The Finance Ministry and the BOT have agreed to work more closely together to develop a coordinated response. While specific measures are yet to be finalised, they will be tailored to the diverse needs of different industries and sectors.
 - ❖ Meanwhile discussions regarding interest rate policies were not part of the meeting, as these fall under the purview of the BOT's Monetary Policy Committee (MPC), which is scheduled to meet next week. The MPC will be closely monitoring international policy trends. Exchange rate policies will be determined based on various factors, including inflation and interest rates, which are subject to fluctuating global conditions.





- PTT plans to import 1 million tons of LNG annually from the United States, valued at around US\$ 500–600 million, as existing supply contracts with other countries are set to expire over the next five years, Finance Minister Pichai Chunhavajira said.
 - ❖ The state-owned energy firm is also considering additional LNG purchases for reexport to neighbouring countries, which would require new investment in storage infrastructure. In addition, PTT aims to import about 400,000 tons of ethane gas from the US next year. The government plans to confirm its commitment to long-term procurement of US gas.
 - ❖ The move comes as Pichai leads a Thai delegation to the US to negotiate over the Trump administration's plan to raise tariffs on Thai exports. Thailand currently runs a trade surplus with the US of approximately US\$40 billion, or 72% of total trade between the two countries. To address this imbalance, Thailand is proposing to expand two-way trade, particularly by increasing imports of US agricultural and energy products.
 - ❖ Pichai added that domestic producers have already agreed to import US corn and soybean meal for use in manufacturing animal feed for export.
 - ❖ The Thai negotiating team, comprising officials from the Ministries of Commerce, Finance, and Foreign Affairs, is set to travel to the US. Initial plans indicate meetings with US counterparts will take place within the week following Easter after April 20th.
- Three consortiums have secured virtual bank licenses, according to news reports:
 - > SCBX, partnering with South Korea's KakaoBank and China's WeBank
 - ➤ Krungthai Bank, teaming up with AIS, OR, and Gulf Energy
 - ➤ Ascend Money (TrueMoney Wallet), in collaboration with China's Ant Group
 - Two applicants did not make the cut:
 - ➤ Bangkok Bank, with BTS Group, Sea Group, Sahapat, and Thailand Post
 - A group led by Chatchaval Jiaravanon, partnered with Singapore's Lightnet and Hong Kong's WeLab

❖ The Bank of Thailand (BoT) is expected to formally announce the licensees by mid-2025. The list will then be submitted to the Finance Minister for final approval, with licenses taking effect from mid-year. The BoT earlier indicated that licensees will need around one year to prepare, with operations likely to launch by June 2026.



- The president of Airports of Thailand Plc (AOT) has reportedly resigned from his position effective April 24, 2025.
 - ❖ The report says that he tendered his resignation on March 24, 2025, ahead of his term ending at the end of April 2025.
 - ❖ Most recently, Keerati Kitmanawat, President of Airports of Thailand Plc (AOT), is expected to submit his resignation soon before the end of his term in April 2027. The move is reportedly due to political pressure, as Keerati was appointed during the tenure of former Transport Minister Saksayam Chidchob.
 - ❖ Keerati has reportedly attempted to negotiate to stay on, but it is said that the order for his departure has come directly from the highest levels of the Pheu Thai Party. All eyes are now on AOT's upcoming board meeting on April 23, where it remains to be seen whether the President will formally tender his resignation.



• The Stock Exchange of Thailand (SET) index closed yesterday at 1,138.90 points, up 10.24 points (+0.91%) with a trading value of 41.2 billion Baht. The rebound aligned with global

markets, which rose in response to the U.S. temporarily suspending tariffs on smartphones, computers, and semiconductors.



- ❖ Additionally, bargain-hunting emerged in several stocks that had declined significantly, particularly in sectors like power plants and globally linked industries such as petrochemicals and packaging.
- ❖ There is also speculation that the Monetary Policy Committee (MPC) may lower the interest rate at its meeting later in April. Meanwhile, profit-taking was seen across several sectors, especially in banking stocks like SCB and KTB, which recently went XD.

- Yesterday, the Securities and Exchange Commission (SEC) reported that Taokaenoi Food & Marketing Plc (TKN) acquired 177,000 shares of Chao Sua Foods Industry Plc (CHAO) on April 11.
 - ❖ This purchase, representing a 0.0590% stake, increased TKN's total holdings to 14.28 million shares, or 4.7626% of CHAO, up from 14.11 million shares. With this increase, TKN has become the 3rd largest shareholder of CHAO.
- Thai beef farmers will rally in front of the Ministry of Agriculture on Thursday, to protest against the government's plan to lift the import ban on US beef and offal into Thailand, as a part of the trade negotiations following the US imposition of 36% reciprocal tariffs on Thai imports to the US market.
 - ❖ On Monday, the Beef Cattle Association of Thailand sent a letter to Prime Minister Paetongtarn Shinawatra and ministers concerned, expressing their opposition to the planned lifting of the import ban on US beef, which it claims will affect more than 1.4 million Thai cattle farming families.
 - ❖ Sitthiporn Boorananath, vice president of the association, claimed that Thai cattle breeders are already being affected by the free trade agreements with Australia and New Zealand, which permit the imports of their beef into Thailand. The import of US beef will contravene Thai law, which prohibits the use of leanness-enhancing agents widely used by American beef farmers.
- Preecha Aem-im, President of the Thai Egg Traders Association, revealed that the Cooperative Network of Hen Farmers has announced a new recommended farm-gate price for mixed-grade eggs at 3.40 Baht per egg, up 0.20 Baht from the previous price of 3.20 Baht, or an increase of 6 Baht per tray. The new price takes effect on April 17.
 - ❖ This marks the first of two planned price hikes, with another 0.20 Baht increase expected in the near future.



- Gold prices jumped 750 Baht after the 26th price update yesterday, setting a new record with gold jewelry retailing at 52,750 Baht per Baht-weight. The Gold Traders Association said spot gold surged to an all-time high, driven by strong safe-haven demand amid uncertainty over U.S. tariff policy.
 - ❖ Internationally, gold hit a record \$3,273 per ounce as investors continued to buy amid concerns over U.S. trade measures. While the U.S. granted temporary tariff exemptions for smartphones, computers, and some electronics from China, Trump said the relief is only short-term. The U.S. is also considering new tariffs on pharmaceuticals and semiconductors.



Earthquake Tragedy

- The ThaiPublica Facebook page revealed findings from the Office of the Auditor General inspections covering fiscal years 2011 to 2022.
 (https://www.facebook.com/photo/?fbid=1099426662225222)
 - ❖ According to the post, the Comptroller General's Department submitted the reports to the Finance Minister, who then presented them to the Cabinet 11 times for acknowledgment before forwarding them to Parliament.
 - ❖ The reports indicated that the procurement and design processes for two OAG building projects may not have complied with official regulations. There were also numerous procurement proposals that were never implemented. For instance, in fiscal year 2015, 90 projects were proposed, but only 47 were carried out.
 - ❖ Particularly concerning were Phases 1 and 2 of the new OAG office building, which had been allocated budgets but saw no disbursement. Audits also uncovered that, from fiscal years 2007 to 2016, a large amount of unspent funds totaling 2.95 billion Baht had been accumulated and left sitting in bank deposit accounts.



- Interior Minister Anutin Charnvirakul stated that the analysis by Professor Emeritus Worsak Kanok-Nukulchai, a Royal Academy member in structural engineering, matched the committee's initial findings on the possible causes of the State Audit Office (SAO) collapse. Both Worsak and the committee believe that an asymmetrical lift shaft could have caused centrifugal force and torque, leading to the collapse.
 - ❖ This followed a police complaint filed by Somkiat Chusangsuk, Chair of the Engineering Clinic at the Engineering Institute of Thailand, after discovering that his name and signature had been forged on documents appointing him as supervising engineer for PKW Joint Venture—the firm overseeing the building's construction. Media reports indicate that the joint venture includes PN Synchronize, Wand Associates Consultants, and KP Consultants and Management. Somkiat also found that the joint venture's registered address is an unoccupied house with no signage.
 - ❖ Anutin added that the investigating committee had requested more time to conduct advanced calculations for accuracy. He emphasized that if the hypothesis proves correct, it could ruin the futures of the designers and companies involved, making it crucial that accusations be made with absolute certainty.



• Chalad Khamchuang, a Member of Parliament for Roi Et from the Pheu Thai Party and Chairman of the Anti-Corruption and Misconduct Committee of the House of Representatives, revealed that on April 30, the committee will invite the Auditor General to explain the collapse of the new Office of the Auditor General building.

❖ The investigation will focus on whether there was any corruption involved in the construction of the building, which had a budget of over 2 billion Baht, and whether the materials used met the required quality standards.



General News

- Two Filipino tourists were injured yesterday when a cliff edge at the Haew Narok waterfall
 in Khao Yai national park crumbled. The waterfall has since been closed to all visitors
 indefinitely.
 - ❖ According to Chaiya Huayhongtong, chief of Khao Yai National Park, a group of about 10 tourists, led by a guide, were on the steep second tier of the waterfall when the cliff edge gave way, after absorbing a lot of water due to heavy rainfall over the past few days.
 - One of the two Filipino tourists who were injured suffered a broken leg.

Background Information
